Hunters Chase Farms Policies

1. Riders must wear an approved horseback riding helmet, boots with a heel, and appropriate riding pants.
2. Board, lessons, and camp are a set price. Fees are due monthly. No credits, carry-overs, deductions, or refunds are given for missed lessons.
3. **Full payment is due by the 25th of the previous month.** Payments received after the 1st incur a **\$25 late fee**, plus **\$10 per week** thereafter. (Checks preferred.)
4. HCF requires **30 days' written notice** before discontinuing lessons, boarding, or reducing lesson frequency.
5. **Lesson Makeup Policy:** Marylaura must receive **at least 24 hours' notice by text message** before a missed lesson. Lessons without proper notice will be forfeited. Approved makeup lessons must be completed within **two weeks**.
6. Lessons are held rain or shine unless weather conditions are extreme. Please call if you are unsure.
7. Policy and release forms must be signed before participating in lessons or camp.
8. No one is permitted on HCF property without HCF approval.
9. Parents are welcome to observe lessons but may not coach or distract riders during lessons or shows.
10. Riders are responsible for cleaning tack and equipment after every ride. Privately owned tack left out may be confiscated and returned after completion of an assigned barn chore.

I/We authorize Hunters Chase Farms, Inc. employees to obtain emergency medical care if a parent/guardian cannot be reached.

I/We release Hunters Chase Farms, Inc., its employees, representatives, and the Doherty, Moore, Bradfield, Keller, and Frey families from liability for bodily injury or death occurring on HCF property or during HCF activities or transportation. I/We understand HCF does not provide accident insurance.

WARNING: Under Texas law (Chapter 87, Civil Practice and Remedies Code), a farm animal professional, owner, or lessee is not liable for injury to or the death of a participant resulting from the inherent risks of farm animal activities.
